## COMMUNITY DEVELOPMENT BLOCK GRANT MONEY: A TOOL FOR NEIGHBORHOODS

MHC will release its second *Issue Paper of 2004* in June. Don't miss this opportunity to learn more about one precious local resource for strengthening neighborhoods — the Community Development Block Grant, or CDBG.

For 30 years, CDBG funds have existed to provide housing and community development support to low-income neighborhoods. Every five years, Metro Government engages in a public planning process to outline community needs and goals, and to direct the allocation of CDBG funds. The planning process begins this summer — which means now is a great time to learn how these funds work and how to get involved on a neighborhood level. Look for your copy in the mail.

## PROPOSED SECTION 8 CHANGES

The Housing Choice Voucher Program, referred to as Section 8 by most of us, faces two very serious challenges. Across the country, this program currently helps 2 million low income families fill the financial gap between 30% of their incomes and the cost of modest rent. In Metro Louisville, 24,574 people rely on a Section 8

voucher to afford decent, stable housing. Of these, nearly 60% are children. Despite a long history of effectiveness and bipartisan support, the Section 8 voucher program is facing cuts in both 2004 and 2005. On April 22, the Bush Administration announced it will retroactively change the way housing vouchers are funded. This

change only serves to radically under fund many housing authorities. Housing authorities across the country are planning terminations and rent increases, and several development deals that depend on Section 8 have fallen through or are at risk of falling through. We do not yet know how the Louisville Metro Housing Authority will respond — but we do know that as of May of 2004 over 12,000 qualified households are on a waiting list for a voucher. This funding cut will ensure that none of these 120,000 people will obtain a

voucher any time soon.

In its 2005 budget, the Bush Administration proposes to cut the program's funding and to restructure the program in a way that would both remove important resident protections and, eventually, deconstruct it completely. Essentially, the proposal involves decreasing funding and then block-granting the remaining funds directly to public housing authorities. The Center for Budget and Policy Priorities estimates that this new "Flexible Voucher Program" will cut Metro Louisville's current Section 8 funding by \$5.4 million in 2005 — and

\$14.6 million by 2009.

The Advocacy Committee of the Metropolitan Housing Coalition and the Coalition for the Homeless are working to respond to these very dire predictions.
