
KENTUCKY HABITAT FOR HUMANITY

Leadership changes strengthen local organizations

In January, **LYNN LUALLEN** joined the Housing Partnership, Inc. as its new Director — replacing our good friend **MARIA GERWING HAMPTON** who now leads the Louisville Branch of the Federal Reserve Bank of St. Louis. No stranger to MHC, Lynn is the former CEO of the Kentucky Housing Corporation for nearly 20 years. ■

On January 26, **KRISTA MILLS** was appointed Field Office Director of the U.S. Housing and Urban Development, Kentucky State Office, replacing **BEN COOK**, who left to lead Kentucky Housing Corporation. Krista came to the Kentucky Field Office as a Community Builder in the 1998, after working as the director of a nonprofit that served homeless women and children in Virginia, where she formed the statewide Coalition for the Homeless. ■

Federal FY2006 budget proposal inadequate to address housing needs

The Administration released a FY 2006 budget proposal on February 7th that included an overall 11.5% cut to the U.S. Department of Housing and Urban Development's budget.

Because the existing resources to meet housing needs in our community are already painfully inadequate (evidence is the qualified 14,000 families on the Section 8 Waiting List), we are alarmed by this proposed loss of funding.

In the FY2006 budget proposal, housing for people with disabilities (Section 811) is cut in half, housing for people with AIDS (HOPWA) is cut by 37%, funding for Fair Housing activities is cut, lead safety program funding is cut, Rural Housing and Economic Development is eliminated, and public & assisted housing is effectively cut.

Perhaps most alarming, the Administration proposes eliminating funding for 18 federal community development programs currently funded by seven federal agencies — including the Community Development Block Grant Program — and combining these into the *Strengthening America's Community Initiative*. This initiative would be administered by the Commerce Department as an economic development block grant serving very low income communities.

The consolidation yields a 35% cut in total community development spending at the federal level.

The implications of this budget for low and moderate income people in our community are severe. The budget inhibits Metro Louisville's ability to achieve its goals of building stronger neighborhoods and communities.

Far from strengthening this commu-

nity, the federal budget proposal undermines on-going community-building efforts and programs. In coordination with the Coalition for the Homeless, **MHC will be responding forcefully to the budget proposals. We will ask for your help.**

A call to advocacy for the Kentucky Affordable Housing Trust Fund

Statewide affordable housing advocates are asking state legislators to commit to \$4 million to the Kentucky Affordable Housing Trust Fund this session for the FY2006 budget. The AHTF has infused \$3,554,484 into Jefferson County and Louisville since 1994. This funding has been leveraged into more than \$24 million in jobs, goods and services pumped into our local economy.

Since last July, we have been operating under Governor Fletcher's spending plan. In that, the Affordable Housing Trust Fund is funded at \$2.5 million.

Since \$1.5 million of AHTF dollars will likely be used for "Recovery Kentucky" — an initiative to construct housing recovery centers throughout the state. Advocates seek to ensure that the Recovery

Kentucky money is added to the current \$2.5 million per year funding level for FY2006, as the statewide need for housing is so great each year.

The Kentucky AHTF addresses the pressing need for decent, affordable housing for low-income families and provides strong economic stimulus and job creation through housing production. Most importantly, it is the only state generated funding for housing the very poor in our Commonwealth. As federal funds are being drastically cut, we need a local increase in support for affordable housing.

Contact your legislator today and request that they stand behind 4 million for the Kentucky Affordable Housing Trust Fund!
