



2014 MHC Legislative Agenda

So much is still being decided, but these are the issues that MHC is currently focusing on and how you can take action:

State level

Join the **Local Options for Kentucky Liens (LOKL)** coalition to give local control of collecting delinquent property taxes back to Kentucky's counties and to update Louisville's Land Bank. MHC is working with many groups in this effort for changes in state law.

MHC continues to advocate for **energy efficient rehab** programs for low income households, particularly as we face rising energy costs. Investments like these have a huge impact in affordability of shelter. There will be a bill in the state legislature that helps support the costs of energy efficient rehab and we will provide more information as the legislative session nears.

Join the state wide group working on revising the **tax structure for low-income households**. Contact MHC about how to join LOKL.

We know that there is a long road ahead for reforming **Payday Lending** and trying to lower the 460% interest rate now allowed, so keep on this issue and let your elected officials know it matters to you.

Work with the newly reconstituted Fairness Campaign on getting a **statewide fairness law** to prevent discrimination in housing and other areas because of gender identity or sexual orientation.

There is an active movement to ensure that low-income people are not unduly burdened by the new **bridge tolls** by allowing them a tax credit. Contact MHC for info.

Local level

Join the movement to have the Louisville Metro Council fund the **Louisville Affordable Housing Trust Fund** through raising the tax on insurance fees (health insurance is exempt) by 1%. Contact the LAHTF at (502) 637-5372 or info@louisvilleahtf.org.

2013 MHC housing report to be released Dec. 10

On December 10, MHC will release our annual State of Metropolitan Housing Report (SMHR). The focus topic of the 2013 State of Metropolitan Housing Report is renters and rental housing. The housing market in Louisville is different from 10 years ago. We have 49,747 more people living in rental housing units in 2012 than in 2005 and a slight drop (4,663 fewer people) in the population living in owned housing units. This also represents a 16 percent increase in the number of rental households and a 2 percent decrease in owner households.

- The 2012 homeownership rate for the Louisville MSA was 63 percent, up slightly from 2011, but still 7 percent lower than when MHC began tracking the figure in the 2003 *State of Metropolitan Housing Report*.
- During the 2012-13 academic year there were 15,316 homeless students in Jefferson County Public Schools, and an additional 1,091 homeless students in the surrounding Louisville MSA counties.
- Louisville Metro Council districts 4 and 6 continue to have the most subsidized housing units in the county, both by number and percentage of total housing units. Nearly all (93 percent) of the county's Low Income Housing Tax Credits are located in council districts 1, 2, 3, 4, 5, 6, and 15.

2013 SMHR (CONT.)

- The living wage in Louisville for an adult with one child is \$17.27; for an adult with two children it is \$21.59. Though these wages are sufficient to afford a two- or three-bedroom rental unit, the typical hourly rate for 68 percent of all workers is below \$17.27 and only 20 percent of the employed workforce makes more than \$21.59.
- The Louisville MSA saw a total of 4,511 foreclosures in 2012, an increase of 91 percent since 2002, but a decrease of 20 percent from 2011

There is a new real estate paradigm and a new reality of how people are housed. Read about MHC's legislative agenda and our work on changing the Land Development Code to see some of MHC's work to change our policies to meet the new reality.

Call for new Land Development Code to match new housing realities

MHC's 2013 *State of Metropolitan Housing Report* shows a dramatic rise in the percent of households who rent, from 33 percent in 2011 to 36 percent in 2012. The Report also has information showing that the median income is not as high as in 2009 and that the Metropolitan Statistical Area for Louisville experienced an increase in the number of students who experienced being homeless in a school year.

We need housing affordable for low wage working families! We need to break the concentrations of poverty that are directly the effect of our zoning policies which exclude BY LAW types of housing that would be responsive to our families. This is not the free market at play, but government mandated policies resulting in segregation.

Join MHC and dozens of other in the effort to revise the Land Development Code. Recommendations that would allow appropriate density in R4 and R5 areas (currently single family housing only) that not only permits multi-family housing, but provides incentives if the development is mixed income. These recommendations were created by a year-long process that involved the development and real estate industries, community leaders and advocates.

Want to learn more and get involved? MHC will come to your group to explain what the recommendations are and to ask that you and/or your group sign on in support of these recommendations, which are now going to be considered by the Louisville Planning Commission.

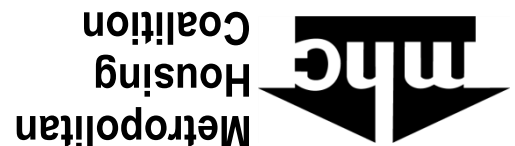
